  - Loans for Non-U.S. Residents: Designed for foreign nationals to purchase or invest in U.S. properties without requiring a U.S. credit history.
- ITIN (Individual Taxpayer Identification Number) Loans
  - Non-Citizen Mortgage Option: Allows individuals without Social Security numbers to secure home loans using their ITIN and alternative credit documentation.
- Bank Statement Loans
  - 12 month or 24 month average of bank statement deposits for income
